This Target Market Determination (TMD) is a publicly available document required under section 994B of the Corporations Act 2001. 2. Class of consumers that fall within this target market

The information below summarises the overall class of consumers that fall within the target market for the U Ethical Australian Equities Trust based on the product key attributes and the objectives, financial situation and needs that it has been designed to meet.

The U Ethical Australian Equities Trust aims to achieve competitive risk adjusted returns over the medium to long-term in accordance with U Ethical's ethical investment policy and ethical investment and stewardship approach. The fund also aims to outperform its benchmark (S&P/ASX 300 Accumulation Index) after fees over rolling 5-year periods.

Product description and key attributes

The key eligibility requirements and product attributes of this fund are:

- a diversified portfolio of ethically screened Australian shares designed to provide income and long-term capital growth
- half-yearly distributions
- minimum initial investment of \$2,000 (or \$1,000 if a regular investment plan is established) with additional investments of at least \$200 thereafter at any time
- the option to reinvest the income distribution in the fund or credit to the investor's nominated Australian bank account
- the ability to redeem some or all of the investment at any time with proceeds made available within 7 business days after U Ethical has received and accepted the completed redemption request
- management fees estimated to be up to 1.315% per annum or \$658 for every \$50,000 invested in the fund

Objectives, financial situation, and needs of the target market

This product has been designed for individuals who:

- seek exposure to an actively managed portfolio
- are looking for capital growth on their investment
- understand that the fund seeks to outperform its benchmark (\$&P/ASX 300 Accumulation Index) after fees over rolling 5-year periods
- are willing to invest into the product for at least 7 to 10 years
- have high tolerance for risk
- have sufficient capital to meet the minimum initial investment of \$2,000 (or \$1,000 if a regular saving plan is established)

Consistency between target market and the product

This product is likely to be consistent with the likely objectives, financial situation and needs of the class of consumers in the target market. This is based on an analysis of the key terms, features and attributes of the product and a finding that these are consistent with the identified class of consumers.

Where a review trigger has occurred, this target market determination will be reviewed within 10 business days.
